A Planned Residential Development

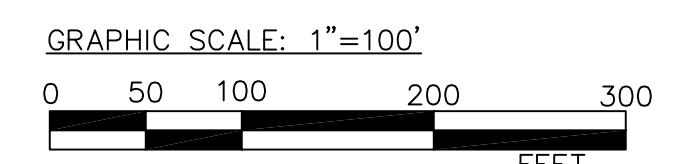

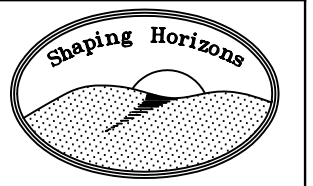
